BBS, aware of its educational and social function, is committed to spreading the culture of equal opportunities and would like to contribute, by facilitating access to education, to bridge the gender gap also.

BBS is making available **five partial tuition waivers** on a first-come, first-served basis, consisting of the possibility of benefiting from a reduction in the Hybrid MBA (International edition) 2021/2022 tuition fee.

Each partial tuition waiver will entitle the first five candidates who meet all the requirements mentioned below to pay a tuition fee of Euro 8,100.00 + VAT, instead of Euro 16,200.00 + VAT, in 4 instalments.

BBS is also making available **five full tuition waivers** on a first-come, first-served basis. Each full tuition waiver consists of exemption from the tuition fee payment of Euro 16,200.00 + VAT (100% of the tuition fee) to the Hybrid MBA (International edition) 2021/2022 for the first five candidates who meet all the requirements mentioned below.

1. Beneficiaries and Requirements

For the **partial tuition waivers**:

- women candidates;
- registration on an individual basis;
- successful outcome regarding the selection process and requirements verification for the Hybrid MBA (International edition) 2021/2022.

For the **full tuition waivers**

- women candidates;
- registration on an individual basis;
- a yearly income below Euro 30,000.00; the beneficiary must self-certify that meet this requirement when accepting the tuition waiver;
- successful outcome regarding the selection process and requirements verification for the Hybrid MBA (International edition) 2021/2022.

The tuition waiver (partial or full) cannot be combined with any other scholarship, award, or financial support. The beneficiary must self-certify that meet this requirement when accepting the tuition waiver.

The beneficiary must comply with this condition for the whole duration of the Hybrid MBA (International edition) 2021/2022.

3. Tuition waivers application deadline and communication of results

If you meet all the requirements, you can apply for just one or both tuition waivers mentioned above. The amount of the tuition waiver assigned (partial or full tuition waiver) is at the discretion of BBS Commission, and their decision is final and unquestionable.

Applications must be sent through by email: eng.hmba@bbs.unibo.it with the deadline indicated below. The assignment is on a first-come, first-served basis; in the event of two or more candidates with the same score, the date you sent the application is to be considered the date to draw up the list of 5 beneficiaries.

Tuition waivers applications are accepted **until December 10, 2021**, unless the deadline is extended. The assignment of the tuition waiver will be formally notified to the beneficiary by BBS Commission through an assignment letter sent by e-mail, no later than one week after you participated in the selection process.

4. Acceptance of the conditions

Application for the tuition waiver involves full acceptance of these conditions. Under penalty of immediate withdrawal, the beneficiary must confirm their enrolment in the Hybrid MBA (International edition) 2021/2022 and formalize her acceptance of all tuition waiver conditions with the Admissions office by the deadline indicated on the tuition waiver assignment letter.
